DRYING

Wanthane[®] materials are supplied pre-dried in moisture guarded bags. Dry Wanthane[®] will rapidly absorb moisture when exposed to atmosphere. For trouble free products, Wanthane[®] WHT-50965 must be dried before processing. It is recommended to dry the material at 90-100 °C for 2-3 h in a circulating air or dehumidified air dryer. The moisture content must be lower than 0.03% before and during processing.

PACKAGING

Wanthane $^{\otimes}$ WHT-50965 is packaged in the form of uncolored transparent pellets in PE-lined bags of 25 Kg net weight (1000 Kg/pallet).

STORAGE

Wanthane[®] should be inspected to assure containers are not broken during transportation. Containers should be stored in a cool and dry environment, and should be brought to room temperature before opening in order to prevent condensation. Once being used, containers with residual materials should be sealed. It is necessary to cover the feed hopper of the processing machine.

PROCESSING RECOMMENDATIONS

Based on our experience, the features of recommended screw are the following:

- 1. L/D ratio between 25 and 30.
- 2. The appropriate compression ratio is from 1:2 to 1:3.
- The screw extruder should have three sections which have continued constant pitch. The distance between screw and barrel should be 0.1 to 0.2mm. Depending on the size and type of the screw and die, the breaker plates used should have holes of 1.5 to 5 mm.
- 4. TPU is shear sensitive, for this reason, the extruder's




